We gladly accept purchase orders from all public agencies (US government, cities, counties, states, colleges, hospitals, etc.). Orders to public agencies will be billed upon shipment of merchandise, with payment due 30 days from the invoice date. Other customers may apply for open account or pay with their choice of credit card (we gladly accept Visa, MasterCard or American Express). Non-government customers interested in obtaining open account should contact our Customer Service Department for details. You may also include a check or money order with mailed orders. Returned checks will be subject to a \$25 service charge.

Special Orders

We try to carry any item you may need. However, in this unique market we understand that often, we may not stock the exact item you are searching for. If you need a specialized piece of equipment or would like a customized kit, please contact your local Forensics Source representative. We will do everything possible to obtain the items you are looking for. Special order items are sold on a non-returnable basis.

Return Policy

Agreement of Non-Export
